The meeting was called to order at 7:05 pm

The minutes from the May CCA Board Meeting were approved.

*Treasurer's Report:* Paid bill for newsletter, general membership refreshments and website.

Corporal Schwaeble – PG Community Police Officer.

Speed sign on Calverton Boulevard was out for couple of weeks ago. Speeding was down a bit. Some Calverton residents were stopped due to speeding. Thank you Corporal Schwaeble and PG police for putting out the speed monitor again.

House on Castleleigh had several calls for service. There were medical emergencies at the house. There was not any type of criminal activity at the house. Corporal Schwaeble is still looking into another situation where one resident of Calverton verbally abused another resident.

The Calverton Neighborhood Watch Walk is coming up on Fri-

day, June 12 from 6:30 to 7:30 pm. Corporal Schwaeble is trying to get the white sign that will announce the walk so that it can be put on Calverton Boulevard.

police cars and officers were at one house for about 20 minutes. No arrests were made and the police left.

One board member mentioned that there have now been two speed traps on Palermo. Thank you Commander Jones and MC police.

#### Committee Reports:

The Directory should be put together this year for 2015-2016.

The membership drive needs to be started.

It would be good to get coupons or giveaways for residents to get when they join. Or have the membership card to be used at various businesses for discounts.

#### New Business:

*Constant Contact* – Calverton Citizens Association News and Happenings email that comes out to broadcast what is happening. It costs \$60/month. You can send as many emails each month as you want. The board approved to continue using Constant Contact for a one year trial period.

The Calverton sign at Galway and Fairland was vandalized again. We need to replace the letters. One board member has talked to a sign company because the letters on the current sign are not bolted and can be removed by hand. It will be a permanent sign where the letters will not be able to be stolen. The board member will get a quote for a new sign.

Outlot A – the corner of Calverton and Gracefield. One board member said that CCA should maintain the area around the Calverton sign so that it looks nice and protects the sign. The CCA said that we will support the upkeep of the grounds around the sign. MC council members Tom Hucker and Marc Elrich are both working on the issue.

Blowfish Restaurant in Maryland Farms was before the PG Liquor Board trying to get a special exception to have karaoke at the restaurant. The entertainment license had been pulled almost two years and at the end of August the restaurant could apply for another. About 15 community members and Major Lloyd from District VI showed up to oppose the special exception because the Blowfish restaurant has had an average of 33 calls of service by the PG Police over the last 5 years. The Liquor Board Chairman asked the community members to work with the owner that night to try to come up with a compromise. The owner withdrew his application before we could talk to him. Major Lloyd said that District VI will try to add more coverage over the next couple months to make sure that the atmosphere and surrounding property of restaurant stays quiet.

CCA received an email regarding leaking pipes in the front yard. WSSC is not responsible for leaking pipes in the front yard. It is the responsibility of the Calverton resident to fix the pipe.

District 14 wrap up took place at the East County Regional Services Center. The topics were the budget, schools, taxes, roads, and transportation. Several Calverton residents attended the meeting.

District 21 wrap up took place at Martin Luther King Middle School. The topics were about the same. One budget change for the PG is that school fees have gone up this year. It cost nearly \$100.00 to rent the room instead of the usual \$4.00.

Calverton Welcome Packet for new residents. Four board members volunteered to work on the packet. We hope to have it available with the new membership drive this fall.

#### Old Business:

*Park at the top of Shanondale* – one board member will contact MC to discuss our ideas for the park to see if Calverton will be

allowed to do something in the park.

The Maydale Nature Center community meeting will be Wednesday, June 10 at 7 pm at the East County Regional Services Center at 3300 Briggs Chaney Road. East County residents want Maydale reopened.



July  $4^{th}$  – got a petting zoo and got 2 face painters. Since July 3 is a holiday for county employees, PG County wants to meet us on July 1 at Calverton Elementary at 7:30 pm in order to deliver tables, chairs, etc. Margaret will put out the flags along Calverton Boulevard. Now we need lots of volunteers to help with all the jobs.

*Noise* – 7 am to 9 pm in PG. If an officer comes out the first time it is a warning, the second warning is \$500.00 fine and the third time is \$1000.00. The noise cannot be heard more than from 50 feet from the noise source. MC has a noise ordinance from 7 am to 9 pm on weekdays and 9 am to 9 pm on weekends. MC has no noise from 9 pm to 7 am on weekdays and no noise from 9 pm to 9 am on weekends.

*Parking problem* – trailer parked over the white line along Galway. It is parked partially on the street and is not within the parking lane. Call non-emergency police number. Vehicles have to park 35 feet from the intersection or intersecting roadways.

# The Rockets' Red, White, and Blue Glare

How did fireworks become America's Fourth of July pastime? by Forrest Wickman

For as long as Americans can remember, the nation has celebrated the Fourth of July by staging grand fireworks shows in public squares and lighting smaller displays at home. Why do we commemorate Independence Day by setting off thousands of small explosions?

Because John Adams wanted us to. Before the Declaration of Independence was even signed, he envisioned fireworks as a part of the festivities. In a letter to Abigail Adams on July 3, 1776, he wrote that

the occasion should be commemorated "with Pomp and Parade, with Shews, Games, Sports, Guns, Bells, Bonfires and Illuminations from one End of this Continent to the other from this Time forward forever more." The first commemorative Independence Day fireworks were set off on July 4, 1777. The Pennsylvania Evening Post wrote that in Philadelphia, "The evening was closed with the ring of bells, and at night there was a



grand exhibition of fireworks (which began and concluded with thirteen rockets) on the Commons, and the city was beautifully illuminated." The paper noted that "Everything was conducted with the greatest order and decorum, and the face of joy and gladness was universal." That same year, fireworks also lit up the sky in Boston, where they were exhibited by Col. Thomas Crafts over the common. By 1783 a large variety of fireworks were available to the public. In 1784 one merchant offered a range of pyrotechnics that included "rockets, serpents, wheels, table rockets, cherry trees, fountains, and sun flowers."
